The Barn at Shagway invites you to register for the **The Barn at Shagway Arts & Crafts Fair June 13, 2026!**

Early Registration: Opens December 31, 2025 Closes January 31, 2026

- Choice of booth location, inside barn or outside
 - 5 Inside barn booths - limited and available upon first request and receipt of registration form and booth fee payment

Regular Registration: Opens February 1, 2026 Closes May 1, 2026

Junior Registration: Opens December 31, 2025 Closes May 1, 2026

- Middle School-High School artists and crafters
- Free entry
- Booth space plus 2 chairs provided by the venue - group presentation layout under tented space

The Barn at Shagway Arts & Crafts Fair is a community event and is open to all mediums of arts and crafts. As a vendor, you will have the opportunity to showcase and sell your original work.

Multi Level Marketing sales are not allowed. Include up to five photos of your work with registration and include one photo of your 10' X 10' booth, or provide your social media links or website with photos of your booth space and setup.

- Booths are limited to 55 total (5 inside the barn, 50 outside) plus Junior vendors
 - Vendors must provide their own tables and chairs. A tent or canopy is highly recommended for outside booths (no stakes please). It is advised to bring side walls in the event of rain.
- Your booth fee will go towards advertising and promoting this event as well as preserving and maintaining the Historic Shagway Barn, Log Inn Cabin, Granary and surrounding grounds.

The Barn at Shagway reserves the right to manage vendor selection.

Rules & Policies

Vendors are expected to display and sell artworks and crafts that are of their own original design and created by the vendor. All work must be safe. The Barn at Shagway reserves the right to reject or deny any work of poor taste or poor quality as presented in registration.

Vendors working in collaboration must all be listed on the registration form.

Vendors are responsible for collecting payment for their works. The Barn at Shagway will not complete sales transactions for any Vendor.

Vendors that are non-compliant with the Rules & Policies will be asked to leave the event and may not be permitted to participate in future events.

Inclement Weather Cancellation

If the event is cancelled by The Barn at Shagway due to inclement weather, vendor booth fee will be credited towards the next date of the vendors preference.

Booth

The Barn at Shagway will allocate 12' X 12' booth space for each outdoor vendor which allows for a 10' X 10' canopy or tent. Booth space is limited to 5 inside the barn and 50 outside in the Barn Backyard. Early registration allows preference of booth location, with limited booth space inside the barn.

Junior Artists and Crafters

Juniors will be provided with one six-foot table by The Barn at Shagway. Additional tables may become available at the conclusion of registration and offered upon request. All Junior booths will be under the tent provided by The Barn at Shagway. Junior artists and crafters who wish to sell their work must be accompanied by an adult to complete the sales transaction. Junior booth spaces will be available until all spaces are filled or until registration closes.

Non-Juried

The Barn at Shagway Arts & Crafts Fair is a Non-Juried event. There will be no prizes given to vendors by the venue.

Booth Fee Payment

Booth Fee is non-refundable. Vendors will be emailed a payment request (Invoice) within 72 hours of submitting the **Registration Form 2026** upon acceptance. **Booth Fee Payment is DUE 7 days after the payment request is sent.**

WAIVER AND RELEASE OF LIABILITY

IN CONSIDERATION OF the risk of injury that exists while renting, hosting or participating in events at THE BARN AT SHAGWAY, LLC (hereinafter the “VENUE”); and

IN CONSIDERATION OF my desire to rent, host or participate in the event at the VENUE and being given the right to participate in the same;

I HEREBY, for myself, my heirs, executors, administrators, assigns or personal representatives, (hereinafter collectively “Releasor,” “I” or “me”, which terms shall also include Releasor’s parents or guardian if Releasor is under the age of 18 years of age), knowingly and voluntarily enter into this WAIVER AND RELEASE OF LIABILITY and hereby release any and all rights, claims or causes of action of any kind arising out of renting and hosting events at the VENUE; and

I HEREBY release and forever discharge THE BARN AT SHAGWAY, LLC, located at 5949 Shagway Rd, Ludington, MI 49431, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, (collectively “Releasees”), from any physical or psychological injury that I may suffer as a direct result of my renting, hosting or participating in events at the aforementioned VENUE.

I AM VOLUNTARILY RENTING AND HOSTING AT THE AFOREMENTIONED VENUE AND I AM RENTING AND HOSTING AT THE VENUE ENTIRELY AT MY OWN RISK. I AM AWARE OF THE RISKS ASSOCIATED WITH RENTING AND HOSTING AT THIS VENUE, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO: PHYSICAL OR PHYSIOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC OR EMOTIONAL LOSS, AND DEATH. I UNDERSTAND THAT THESE INJURIES OR OUTCOMES MAY ARISE FROM MY OWN OR OTHER’S NEGLIGENCE, CONDITIONS RELATED TO TRAVEL TO AND FROM THE VENUE, OR FROM CONDITIONS AT THE VENUE LOCATION(S). NONETHELESS, I ASSUME ALL RELATED RISKS, BOTH KNOWN AND UNKNOWN TO ME, OF MY RENTING AND HOSTING AT THIS VENUE.

I FURTHER AGREE to indemnify, defend and hold harmless the Releasees against any and all claims, suits, or actions of any kind whatsoever for liability, damages, compensation, or otherwise brought by me or anyone on my behalf, including attorney's fees and related costs.

I FURTHER ACKNOWLEDGE that Releasees are not responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of Releasees. In the event that I should require medical care or treatment, I authorize THE BARN AT SHAGWAY, to provide all emergency medical care deemed necessary including but not limited to, first aid, CPR, emergency medical transport, and sharing of medical information with medical personnel. I further agree to assume all costs involved and agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

I FURTHER ACKNOWLEDGE that this VENUE may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. I agree not to rent or host at the VENUE unless I am medically able and physically capable of renting and hosting at the VENUE.

I HEREBY ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS "WAIVER AND RELEASE OF LIABILITY" AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE THE BARN AT SHAGWAY, LLC AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS AND ASSIGNS, FROM ANY AND ALL CLAIMS OR CAUSES OR ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST THE BARN AT SHAGWAY, LLC FOR PERSONAL INJURY OR PROPERTY DAMAGE.
